**MEMORANDUM OF AGREEMENT AND STATEMENT OF PARTICULARS.**

WHEREAS an Agreement (the Agreement) between the parties was entered into on 8<sup>th</sup> November 2000 with respect to work performed by employees of Thiess Services Pty Ltd at the Blue Mountains Waste Management Facilities, and other landfall and recycling facilities with in the city of the Blue Mountains (IRC 5770 of 2000).


AND WHEREAS the parties have agreed to extend the application of the Agreement as provided herein,

IT HAS BEEN AGREED AS FOLLOWS:

1. With respect to Clause 3 of the Agreement, the Application of the Agreement shall be varied by extending the Application to include the Hawkesbury Waste Management facility at the Driftway, South Windsor and any facility operated in conjunction therewith.
2. All other provisions of the agreement shall remain as originally agreed, including with respect to Settlement of Disputes.
3. This variation shall commence on and from the date hereof and shall continue for the life of the Agreement, that is, until 30 December 2002.
4. The parties declare that nothing in this variation constitutes a detriment to any employee covered hereby.


